NOTICE 1663 OF 2009

DEPARTMENT OF TRADE AND INDUSTRY

RECTIFICATION OF THE COMPANIES ACT, 2008 (ACT NO. 71 OF 2008)

On April 2009, the President of the Republic signed into law the Companies Act, 2008 (the Act). The Act will come into legal force in 2010 through a proclamation to be issued by the President. The proclamation will provide a specific date on which the Act will come into legal force.

It has come to my attention that there may be errors that require rectification before the implementation of the Act. These errors relate to provisions that appear to be incomplete as well as grammatical, technical and incorrect cross references, which may give rise to different interpretation of the provisions concerned.

In order to address this, the Department of Trade and Industry (the dti) has initiated a process to rectify the identified errors and is hereby requesting stakeholders to give input or comment on the relevant provisions.

COMPANIES ACT NO. 71 OF 2008**ISSUES FOR RECTIFICATION****Purpose**

The purpose of the rectification process is to correct mistakes that have occurred during the processing of the Companies Bill through Parliament.

Scope of Rectification

Errors identified are confined to grammatical errors, incorrect reference and cross referencing, missing of words, inconsistency of provisions and incorrect spelling.

Provisions that require rectification

The Department of Trade and Industry has identified the following errors in the Companies Act No.71 of 2008:
